■ Terms of Use

Please read the Terms of Use and check the box for agreement.

These Terms of Use ("Terms"), outlined by theFACTORY ("Company"), will govern the use for the facilities provided by this climbing gym ("Facilities"). Registered members ("members") are requested to use this service in accordance with this agreement.

Article 1 (Application)
This agreement shall apply to all relationships between the member and the Company regarding the use of the various facilities.

Article 2 (Membership Registration)
A person who wishes to use the facilities shall apply for registration in accordance with the method specified by the Company, and the registration shall be completed when the Company approves the application.
The Company may not approve an application for registration if it determines that the applicant has any of the following reasons, and the Company shall not be obligated to disclose any of the reasons. (1) In the event that false information is provided in the application for registration of use. (2) If you do not comply with these terms and conditions and other rules. (3) If the member has been expelled from the Company or other sports facilities in the past. (4) When exercise is prohibited by a doctor (pregnancy, etc.) (5) In the case of a nationally notifiable infectious disease, skin disease, mental illness, etc.

Article 3 (Treatment of Minors)
1. Junior high school students and younger shall register as members in accordance with Article 2 with the consent of their parent or guardian.
In this case, the person with parental authority shall be jointly and severally liable with the person in question until the month following the month in which the person turns 20 years old, as if the person had become a member by themselves.

Article 4 (Usage Fees and Payment Method)
Members shall pay the usage fees separately determined by the Company by the method designated by the Company.

Article 5 (Suspension of Use of Facilities, etc.)
The company reserves the right to suspend or discontinue the use of all or part of the facilities without prior notice to members in the event that it deems any of the following to be true (1) In the event that false information is provided in the application for registration of use. (2) To perform maintenance, inspection, or renewal of the facilities. (3) For use in schooling, special events, etc.(4) In other cases where the Company deems it difficult to use the facilities.
The Company shall not be liable for any loss or damage suffered by members or third parties due to the suspension or interruption of the use of the various facilities, regardless of the reason.

Article 6 (Exemption from Liability for Damages of the Company)
The Company shall not be held liable for any compensation for damage to persons or property caused by reasons not attributable to the Company when members use the facilities, or for theft or loss of personal belongings managed or stored by members themselves.

Article 7 (Member's Liability for Damages)
In the event that a member causes damage to the Company or a third party while using the facilities, the member shall be responsible for compensation.

Article 8 (Restriction of Use and Cancellation of Registration)
The company reserves the right to restrict the use of the facilities or cancel the registration of members without prior notice in the following cases.
(1) If you violate any of the provisions of this Agreement. (2) When it is found that there is a false fact in the registered information.
(3) In any other cases where the Company deems the use of the facilities to be inappropriate.
In the event that you fail to cooperate with other members or otherwise disrupt the orderly management and operation of the facility. In the event of intentional damage to or theft of facilities or equipment. In the event of an act that is deemed to be detrimental to the dignity of the member. In the event that business activities or sales activities are recognized in the facility. In the event that the use of the facilities causes significant confusion to the company or its employees due to unreasonable or unjust demands. The Company shall not be liable for any damages incurred by members as a result of actions taken by the Company in accordance with this Article.

Article 9 (Changes to the Terms of Use)
The company reserves the right to change this agreement at any time without notice to members if it deems it necessary.

Article 10 (Protection of Personal Information)
We will comply with laws, regulations, guidelines, and other standards regarding the protection of personal information.
The Company shall not use the personal information provided by a prospective member in the application form for registration in Article 3 for any purpose other than the operation of the Company, the provision of services, and personal authentication, except when disclosure is required by law. However, this does not apply in cases where consent has been separately obtained from the member.
